



1. About This Policy

5. What Type of Information is Collected from You?

When you access our website:

There is “Device Information” about your computer hardware and software that is automatically collected by SkilledBuild Limited. This information can include:

- Cookies
- Operating system
- IP address
- Browser information (e.g., type, language, and history)
- Access times
- Settings
- Referring website addresses
- Other data about your device to provide the services as otherwise described in this policy

- Location information (we may receive your generic location, such as city or neighbourhood)

6. **How is Your Information Used?**

Our use of your personal data will always have a lawful basis, either because it is necessary to complete a booking or because it is in our legitimate interests.

We require the information outlined in the previous section to understand your needs and provide you with a better service, and in particular for the following reasons:

We may use the information to customise the website according to your interests.

7. **Who Has Access to Your Information?**

SkilledBuild Limited protects the information maintained on the systems from loss, misuse, unauthorised access or disclosure, alteration, or destruction. We will not sell, distribute, or lease your personal information to third parties. Any personal information we request from you will be safeguarded under current legislation.

We will endeavour to take all reasonable care, in so far as it is possible to do so, to keep your information secure, but, in the absence of negligence on our part we cannot be held liable for any loss if a third party procures unauthorised access to any data we hold.
